

## **Landscaping Maintenance**

The City of Darlington is accepting bids for the landscaping maintenance of several areas for Fiscal Year 2017-2018, July 1 through June 30. Maps are attached in this packet.

- **A.** Entrance at Indian Branch Road and 401: Area is a City-owned lot. Work to include weed control, trimming bushes and trees as needed and placement of pine straw 4 times per year (early April, June, mid-August, November).
- B. Entrance at the U.S. 52 Bypass (Auddie Brown/flag area): Work to include weed control, trimming bushes and trees as needed and placement of pine straw 4 times per year (early April, June, mid-August, November).
- C. Entrance at the U.S. 52 Bypass (Verizon corner): Areas to include the strip from Express Lane to the 52-52 intersection and the area around the brick pillar on the opposite side of South Main Street in front of O-Reilly's Auto Parts. Work to include weed control, trimming bushes and trees as needed and placement of pine straw 4 times per year (early April, June, mid-August, November).
- D. **Islands on SC 34 near the SC151 Spur:** Areas to include the three islands near Sav-Way. Work to include weed control, trimming bushes and placement of pine straw 4 times per year (April, June, August, October).
- E. **Island on South Main Street:** Island located in front of Mitchell-Josey Funeral Home. Work to include weed control, trimming bushes and trees as needed and placement of pine straw 4 times per year (April, June, August, October).
- F. **McLeod Entrance (SC 34):** Area around the brick pillars on either side of the road. Work to include weed control, trimming bushes as needed and placement of pine straw on a semi-annual basis (April and August).
- G. **Entrance at Washington Street:** Work to include weed control, trimming bushes and trees as needed and placement of pine straw 4 times per year (early April, June, mid-August, November).
- H. **Psillos Garden:** Park on North Main Street between North and Evangeline Streets. Work to include trimming trees and bushes, weed control, and placement of pine straw on a semi-annual basis (April and August).
- I. **Rose Garden:** City-owned park in the 400 block of Pearl Street between the City Administration Building and the Darlington County Council on Aging. Work to include weeding the various beds, pruning the bushes, and replacement of pine straw on a semi-annual basis (April and August).

**Requirements:** All businesses must obtain and maintain a current City of Darlington business license to be paid. Proof of workers compensation and liability insurance as well as a completed W-9 must be provided.
